TERMS AND CONDITIONS

Payment terms

- The terms of payment are strictly thirty (30) days from the end of the month of invoice (or such other period as nominated by the supplier herein) from the date of invoice. Britton Brothers Proprietary Limited ACN 009 478 586 trading as Britton Timbers ABN 28 009 478 586, Hasell Britton Pty Ltd ACN 002 990 347 trading as Britton Timbers ABN 15 002 476 360, Raseli Britton Pty Ltd ACN 002 990 347 Idahiga S Britton Timbers ABN 15 002 990 347, Alexander Sturrock & Sons Proprietary Limited ACN 004 073 385 trading as Britton Timbers ABN 35 004 073 385, Britton Timbers International Pty Limited ACN 009 483 425 trading as Brittons Timbers International Pty Ltd ABN 40 009 483 425 and their related bodies corporate (as that term is defined in the Corporations Act 2001) (Supplier) may, at any time, upon the provision of 48 hours' written notice to the Applicant, vary the terms and conditions of trade
- The Supplier is not required to provide any goods, products or services to the Applicant based on quotation until the Supplier has approved the Applicant's credit application. If the Applicant does not agree with the variations proposed by the Supplier, they must
- notify the Supplier in writing within fourteen (14) days from receipt of the written notice that the variations are not agreed to. The Supplier and/or the Applicant will then be at liberty to suspend/withdraw credit facilities if no agreement can be reached between the parties regarding the proposed variations. Absent notice from the Applicant, the varied terms and conditions of trade may be deemed accepted. Clerical errors (such as spelling mistakes or grammatical errors) may be subject to correction without notification.
- The Applicant must check all invoices and advise the Supplier of any errors or omissions within seven (7) days of receipt. Failing advice from the Applicant that the invoice contains any errors or omissions, the invoice may be deemed accepted by the Supplier.
- Should the Applicant not pay for the goods or services supplied by the Supplier in accordance with the credit terms as provided herein, or as agreed in writing by the Supplier and Applicant from time to time, after issuing a written demand to the Applicant demanding payment within fourteen (14) days, the Supplier will be entitled to charge an administration fee of 10 percent of the amount of the invoice payable.

Quotation terms

- Any quotation provided by the supplier is valid for thirty (30) days from the date of issue, or as otherwise agreed in writing.
- The Supplier reserves the right to charge the Applicant for any changes made after an order is made, including cancellation, amendment either in full or part, including the recovery of any cost of special products or materials, toolage or labour to the date of the cancellation or amendment.

Delivery and Inspection

- Any date or time for delivery stated in a quotation by the Supplier is an estimate only. The Supplier will endeavour to meet all delivery estimates provided, however failure to do so will not give rise to grounds for cancellation or termination, or claim for loss and damages by the Applicant. The Supplier will provide reasonable notice to the Applicant of any changes to the delivery times and notice ahead of the initial estimate provided. The Applicant is obligated to immediately examine products upon delivery by the
- Supplier.
- The Applicant must provide written details of any claim of mis-delivery, shortage, defect or damage within 14 days of delivery. The Supplier is not liable for any claim received after 14 days of the delivery.

Jurisdiction

- The Applicant acknowledges and agrees that this agreement will be governed by the laws of the state in which the Supplier trades in, and the laws of the Commonwealth of Australia which are in force in the relevant jurisdiction.

 The Applicant acknowledges and agrees that any contract for the supply of goods or services between the Supplier and the Applicant is formed at the address of the Supplier. The parties to this agreement submit to the non-exclusive jurisdiction of the courts of the supplier and the suppl
- relevant jurisdiction from which the Supplier trades from and the relevant federal courts and courts competent to hear appeals from those courts.

- Security/charges

 14. The Applicant charges in favour of the Supplier all of its estate and interest in any real property, whether held in its own right or as capacity as trustee, the Applicant owns at present and in the future with the amount of its indebtedness hereunder until discharged. The Applicant charges in favour of the Supplier all of its estate and interest in any
- personal property, whether held in its own right or as capacity as trustee, the Applicant owns at present and in the future with the amount of its indebtedness hereunder until

Purpose of credit

Formation of contract

- Quotations made by the Supplier will not be construed as an offer or obligation to supply in accordance with the quotation. The Supplier reserves the right to accept or reject, at its discretion, any offer to purchase received by it upon provision of written reasons to the Applicant. Only written acceptance by the Supplier of the Applicant's offer will complete a contract.
- Placement of an order, either verbally or in writing, will imply acceptance of the Supplier's offer and of these terms and conditions.

Retention of title

- Title in the goods does not pass to the Applicant until the Applicant has made payment in full for the goods and, further, until the Applicant has made payment in full of all the other money owing by the Applicant to the Supplier (whether in respect of money payable under a specific contract or on any other account whatsoever).
- Whilst the Applicant has not paid for the goods supplied in full at any time, the Applicant agrees that property and title in the goods will not pass to the Applicant and the Supplier retains the legal and equitable title in those goods supplied and not yet sold.

 Until payment in full has been made to the Supplier, the Applicant will hold the goods in a

- The Applicant agrees that whilst property and title in the goods remains with the Supplier, the Supplier has the right, with prior notice to the Applicant, to enter upon any premises occupied by the Applicant (or any receiver, receiver and manager, administrator, liquidator or trustee in bankruptcy of the Applicant) to inspect the goods of the Supplier and to repossess the goods which may be in the Applicant's possession, custody or
- control when payment is overdue.

 Cancellation of terms of credit

- The Supplier reserves the right to withdraw credit at any time upon provision of 48 hours' written notice.
- Upon cancellation with notice, all liabilities incurred by the Applicant become due and payable to the Supplier within seven (7) days.

Indemnity

The Applicant agrees to indemnify the Supplier and keep the Supplier indemnified against any claim that arises out of the goods and services supplied under this agreement. This indemnity includes any legal fees and expenses the Supplier incurs in order to enforce its rights, on an indemnity basis.

Provision of further information

- The Applicant undertakes to comply with any reasonable written requests by the Supplier to provide further information for the purpose of assessing the Applicant's creditworthiness, including an updated credit application.
- If the Applicant is a corporation (with the exception of a public listed company), it must advise the Supplier of any alteration to its corporate structure (for example, by changing directors, shareholders, or its constitution). Subject to clauses 44 and 46, payments by, or on behalf of, the Applicant will be applied
- by the Supplier as follows
 - (a) Firstly, in payment of any and all collection costs and legal costs in accordance with clauses 24 and 44.
 - Secondly, in payment of any interest incurred in accordance with clause 50.
- (c) Thirdly, in payment of the outstanding invoice(s). In circumstances where the Supplier seeks to enforce a purchase money security interest under the PPSA over collateral or proceeds (these terms being consistent with the terms defined in the PPSA), payments received from the Applicant will be allocated in a manner at the Suppliers absolute and unfettered discretion, so as to attribute, to the greatest extent possible, the unpaid balance of the debt to the purchase money obligation in respect of the collateral and/or proceeds over which the Supplier seeks to enforce its purchase money security interest.

- The Supplier is not liable for any loss caused to the Applicant by reason of strikes, lockouts, fires, riots, war, embargoes, civil commotions, acts of God or any other activity beyond the Supplier's control.
- In relation to the supply of goods, the Supplier's liability is limited to:
